MASTERING THE IMPLEMENTATION AND MANAGEMENT OF A SUPPLY CHAIN SECURITY MANAGEMENT SYSTEM (SCSMS) BASED ON ISO 28000

### SUMMARY

This five-day intensive course enables the participants to develop the necessary expertise to support an organization in implementing and managing a Supply Chain Security Management System (SCSMS) based on ISO 28000. Participants will also gain a thorough understanding in best practices used to implement supply chain security controls from all areas of ISO 28001. This training is consistent with the project management practices established in ISO 10006 (Quality Management Systems - Guidelines for Quality Management in Projects). This training is fully compatible with ISO 28004 (Guidelines for the Implementation of an SCSMS).

- ▶ Definition of the scope of an SCSMS
- ▶ Development of SCSMS and Supply Chain Security policies
- ▶ Selection of the approach and methodology for security risk assessment
- ▶ Security risk management (identification, analysis and treatment of risk)
- ▶ Development of a security plan

### DAY 3 Implementing an SCSMS based on ISO 28000

- ▶ Implementation of a document management framework
- ▶ Implementation of processes and controls
- ▶ Development of a training & awareness program and communication about the supply chain security
- ▶ Operations management of an SCSMS

### DAY 4 Controlling, monitoring and measuring an SCSMS and the certification audit of an SCSMS

- ▶ Controlling and monitoring the SCSMS controls
- ▶ Development of metrics, performance indicators and dashboards
- ▶ ISO 28000 internal audit and management review of an SCSMS
- ▶ Implementation of a continual improvement program
- ▶ Preparing for an ISO 28000 certification audit

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can understand, interpret and provide guidance on how to implement and manage a Supply Chain Security Management requirements based on best practices of ISO 28000

### 3 Domain 3: Planning an SCSMS based on ISO 28000

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can plan the implementation of an SCSMS in preparation for an ISO 28000 certification

### 4 Domain 4: Implementing an SCSMS based on ISO 28000

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can implement the processes and security controls of an SCSMS required for an ISO 28000 certification

### 5 Domain 5: Performance evaluation, monitoring and measurement of an SCSMS based on ISO 28000

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can evaluate, monitor and measure the performance of an SCSMS in the context of an ISO 28000 certification

### 6 Domain 6: Continual improvement of an SCSMS based on ISO 28000

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can provide guidance on the Continual improvement of an SCSMS in the context of ISO 28000

### 7 Domain 7: Preparation for an SCSMS certification audit

Main Objective: To ensure that the ISO 28000 Lead Implementer candidate can prepare and assist an organization for the certification of an SCSMS against the ISO 28000 standard
