SUMMARY

ISO 14001 is the latest stage in the ISO 14001 revision process. This two-day course includes the most recent information and interpretation of the ISO 14001:2015 requirements.

This course enables participants to acquire the necessary knowledge to support an organization in their process of transitioning to ISO 14001:2015. Participants will learn the different components on how to plan and implement the transition to the new version of the standard. Moreover, the training course will also explore on the time frame of implementation and the influence on current processes.

EXAMINATION AND CERTIFICATION

The PECB Certified ISO 14001:2015 Transition exam fully meets the requirements of the PECB Examination and Certification Program (ECP).

The exam covers the following competence domains:

1 Domain 1: Fundamental principles of environmental management

Main Objective: To ensure that the candidates can understand, interpret and illustrate the main environmental management principles and concepts related to Environmental Management Systems based on ISO 14001:2015.

2 Domain 2: Understanding the high-level structure application on the EMS

Main Objective: To ensure that the ISO 14001:2015 Transition candidates understand the high-level structure based on Annex SL, and is capable of applying it to the Environmental Management System.

3 Domain 3: Understand, interpret and plan the ISO 14001 changes

Main Objective: To ensure that the candidates can understand, interpret and plan the necessary changes made in ISO 14001.

4 Domain 4: Planning the EMS transition based on ISO 14001

Main Objective: To ensure that the candidates can plan the implementation of ISO 14001:2015 transition changes.

5 Domain 5: Understanding the difference between ISO 14001:2004 and ISO 14001:2015

Main objective: To ensure that the ISO 14001:2015 Transition candidates understand the main changes of the standard and can implement them during the transition process.

6 Domain 6: Continual improvement of an EMS based on ISO 14001

Main objective: To ensure that the ISO 14001:2015 Transition candidates can provide guidance on the continuous improvement of the EMS in the context of ISO 14001:2015

- ▶ The exam is paper-based, lasting 2 hours and it contains 45 exam questions (multiple-choice, matching, fill in the blanks, and true/false).
- ▶ The exam is available in English only.

After successfully completing the exam, the candidate will receive a certificate documenting the positive completion of the course and examination.

The certificate will be issued by PECB, and will be sent to participants via e-mail.

GENERAL INFORMATION

- ▶ Exam and certification fees are included in the overall training price.
- ▶ A student manual containing over 120 pages of information will be distributed to participants.
- ▶ A participation certificate of 7 CPD (Continuing Professional Development) credits will be issued to participants.
- ▶ In case of failure of the exam, participants are allowed to retake the exam for free under certain conditions.
